1 Respective responsibilities of the body and the auditor

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.:

- The figures in Boxes 3 and 6 for the current and prior years have been stated gross of VAT. These should be stated net of VAT as the smaller authority prepares its AGAR on an income and expenditure basis. The figures in Section 2, Boxes 3 and 6 for the prior year should read £12,492 and £34,384 respectively, and for the current year should read £3,281 and £48,488 respectively.
- Information received from the smaller authority indicates that assets purchased during the year have not been included in Section 2, Box 9.
