A discussion took place regarding the Relief Road and Cllr Cooke spoke regarding the relationship between KCC and MBC and stated that MBC had now issued a Judicial Review against KCC.

Cllr Govett summarised the discussions and thanks Cllr Cooke for his report.

#### 9. MBC Ward Councillors Report.

MBC Councillor Fort gave her report to the meeting.

She reported that MBC had held a Strategy Day for MBC Councillors to look at the future vision for Maidstone.

## 10. Highways Matters.

Members discussed the issue of HGVs in the Parish and what action could be taken to stop this.

Cllr Cooke stated that he and Highways Officer Sue Laporte had looked at the signage and this was adequate, he stated that the police were not supporting Lorry Watch and therefore this was no-longer being undertaken in the Parish.
